Interested contractors/suppliers are required to register in the Office of Procurement Regulation (OPR) Depository, publish their profiles and request pre-qualification. Kindly refer to the following OPR Depository link: <https://oprtd.org/procurement-depository/>. Submissions must be made in the English Language.

NB: Only contractors/suppliers requesting pre-qualification for the above-listed services **on or before 29th November 2024 @ 4:00pm - (AST)** will be considered for pre-qualification and subsequent invitation to the respective procurement activities. The closing date for pre-qualification requirements clarifications is **on or before 22nd November 2024 @ 4:00pm (AST)**. Queries/clarifications regarding the above procurement activities should be sent to the following email address: ITBProcurementReps@heritage-tt.com. Submissions made for pre-qualification **outside of the OPR Depository will not be accepted**.

1. Eligibility for pre-qualification will be a pass/fail based on the submission of the following documents on the OPR Depository.
 - a) Name, address, telephone number and email of the individual or firm legal registered name
 - b) Company profile and organisation structure
 - c) Certificate of incorporation/amendment and the relevant articles or business registration certificate.
 - d) List of Directors/Owners/Shareholders/Partners
 - e) **Valid** Value Added Tax (VAT), Income Tax (BIR) **Clearance Certificates** and National Insurance Board (NIB) **Compliance Certificate** or Letter of Exemption no older than three (3) months.
 - f) A Bank reference letter indicating whether credit facilities are available and the digit factor, e.g. "high six- figure", no older than three (3) months.
 - g) Last three (3) years' audited financial statements or management accounts which **must** be signed by two (2) Directors/Owners.
 - h) Evidence of insurance coverage, a copy of which must be uploaded, e.g. public liability, workmen compensation, motor vehicle and all risks or any other relevant type of insurance.
 - i) Key employees and their detailed CVs showing demonstrable experience.
 - j) Key references showing the company's demonstrable experience in providing the relevant services listed above e.g., a List of key contracts executed relevant to the services listed above.
 - k) Key equipment inclusive of software relevant to the services listed above.
 - l) HSE policies, industry standards - vendors **must** be STOW-TT or equivalent (ISO 9001/14001/45001) certified for the services listed above.
